# **ELIGIBILITY CRITERIA:-**

# <u>Age :</u>-

Should have completed minimum 18 years of age but should not be more than 26 years of age, as on <a href="Mailto:2016"><u>Oct.2016</u></a>. Relaxation shall be granted in the upper age limit as per Government guidelines admissible to SC/ST/OBC/PWD/Ex-servicemen candidates and as mentioned below:

Note: i) The relaxation in upper age limit to SC/ST/OBC candidates is allowed on cumulative basis with only one of the remaining categories for which age relaxation is permitted.

ii) The maximum age limit specified i.e.26 years is applicable to General category candidates.

# **Educational Qualification:-**

- The candidates should be "A pass in Xth Standard examination or its equivalent."
- The candidate should be able to read and write in local vernacular language. Knowledge of English will be given added weightage.

# **APPLICATION FEES**:

Application Fees/ Intimation Charges Payable (Online payment) shall be as follows
